



**FEES ASSOCIATED WITH CONDUCTING RESEARCH
ON
TALL TIMBERS RESEARCH STATION PROPERTY**

Tall Timbers Research Station (TTRS) is a **private non-profit** entity dedicated to conducting research on the ecology of fire and on ecosystems in the southeastern US coastal plain. The following fees have been instituted to cover costs to TTRS for research support typically requested by visiting scientists that have no formal or grant affiliated joint research projects with a station scientist as a co-PI. Note that we are not financially affiliated with any university, government organization or other organization therefore any project proposed on Tall Timbers must pay its way. Assistance whether it be office space, lab space, storage space, administrative support, or for any assistance requiring station personnel or equipment is charged at the below rates.

Administrative Fee - \$100

Office, Lab, and storage space – @ \$11/square foot/year (1 year minimum)

Copier use, supplies and postage – actual expenses

Lodging – subject to availability (Contact Lisa Baggett x241 for availability)

Land Management Fees – are applied to any experiment that is conducted on station properties requiring monitoring, site manipulation or assistance in any way. These fees are based on the most current rate schedule used by the Florida Landowners Incentive Program overseen by the Florida Fish and Wildlife Commission. A rate sheet is available upon request.

Overhead – 20% of the above costs (except housing)

Not Provided – Vehicles, meals, housekeeping service.

Researcher Responsibility: Once a project has been approved, researchers, research assistants, students and other are obligated to pay all fees that apply to facilities use and services they have requested. Principle Investigators are financially responsible for all team members they employ. Those delinquent in payment will not be allowed station access until all bills are paid. Accounts are considered delinquent after one year and the PI will be responsible for collection and interest fees beyond that point. Fees are billed quarterly, except the Administrative fee (\$100) which must be paid upon project approval.

Exceptions: Only by the Director of Research and in writing.
